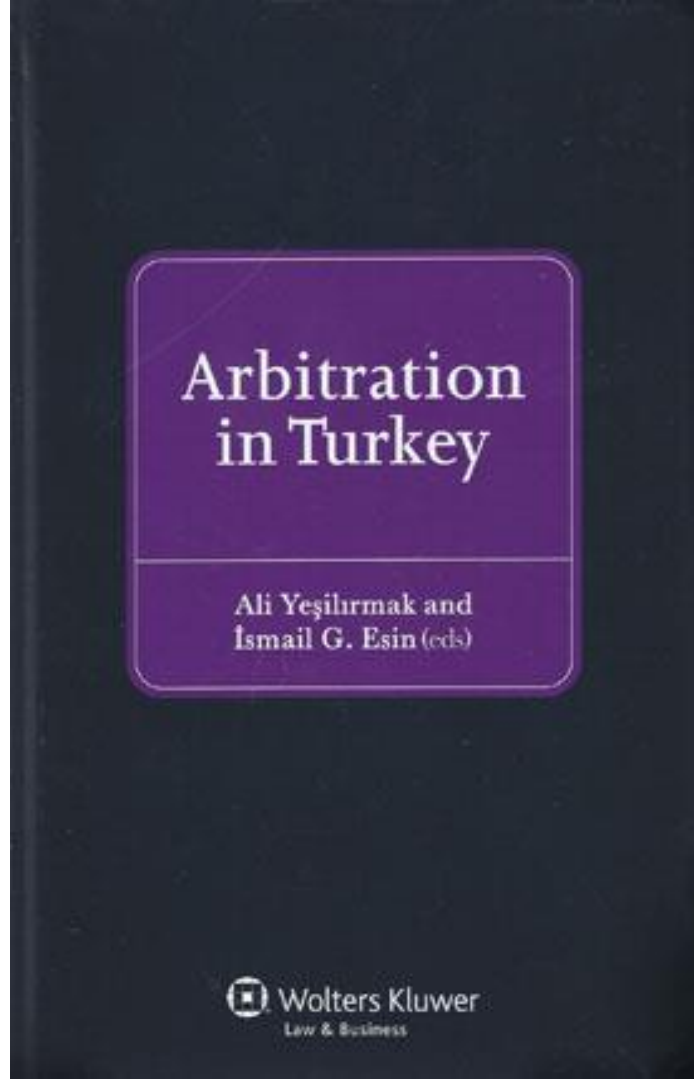

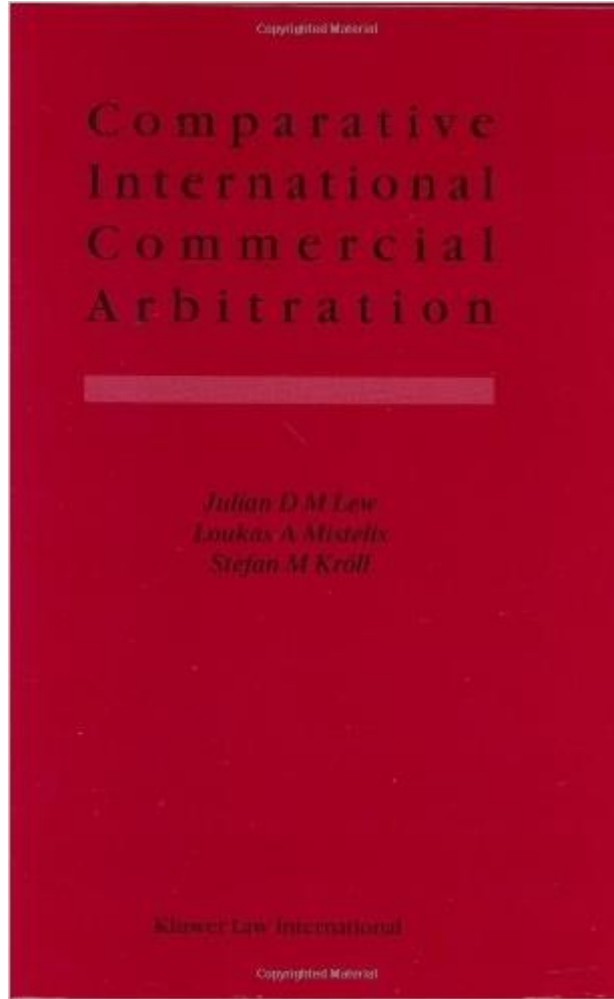

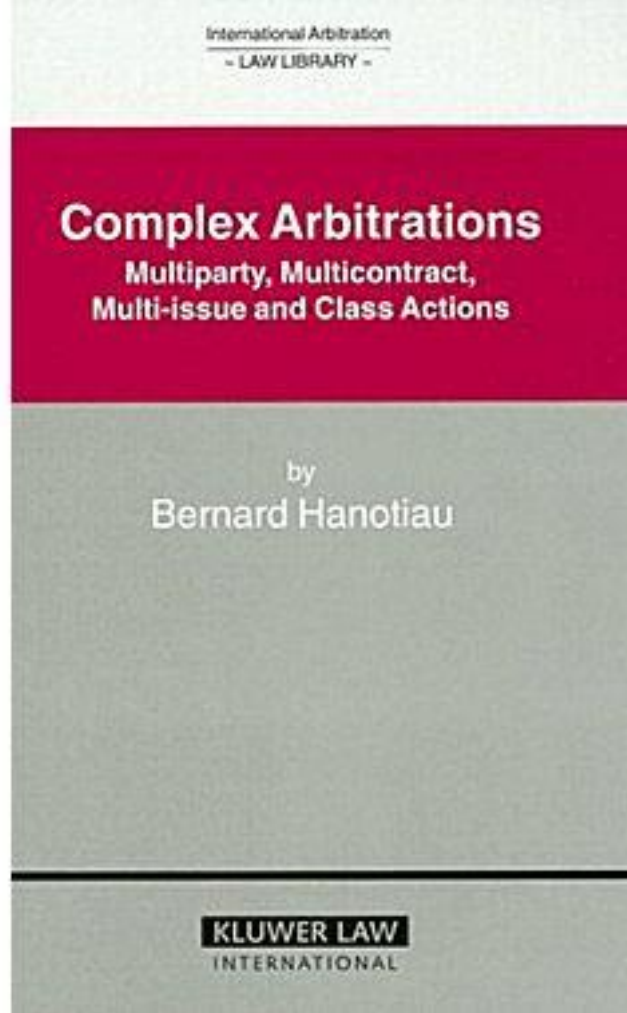

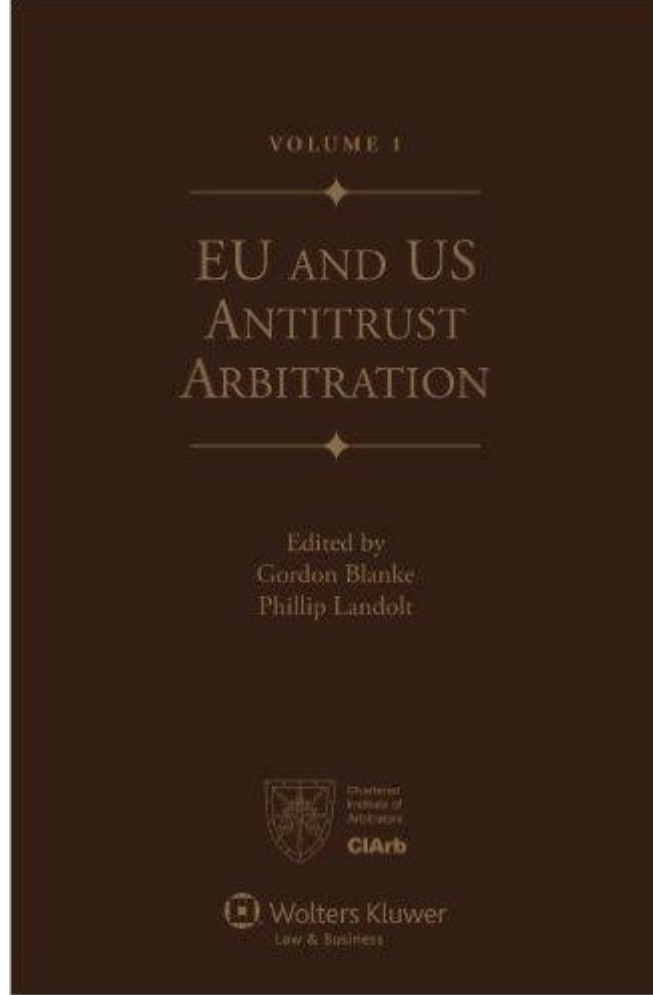

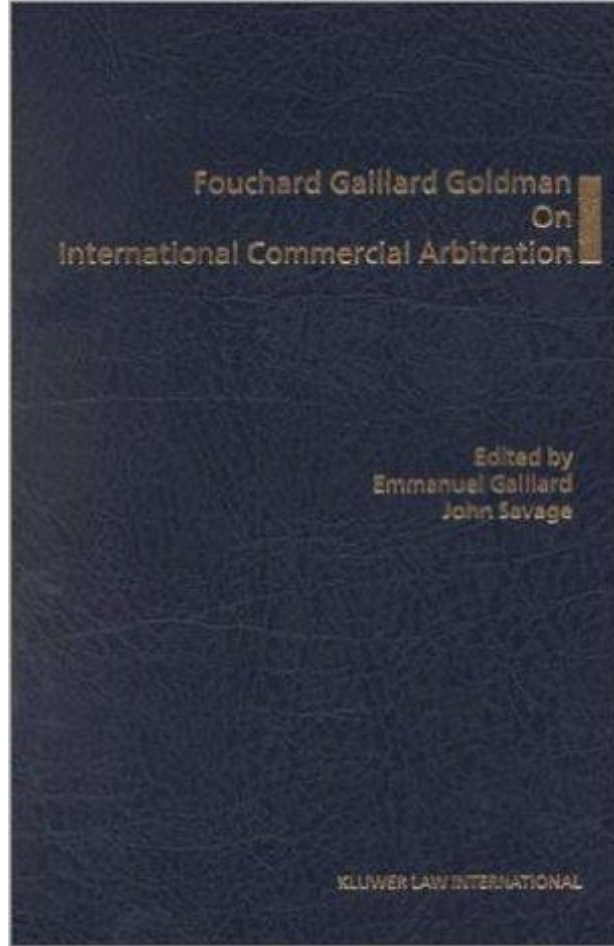

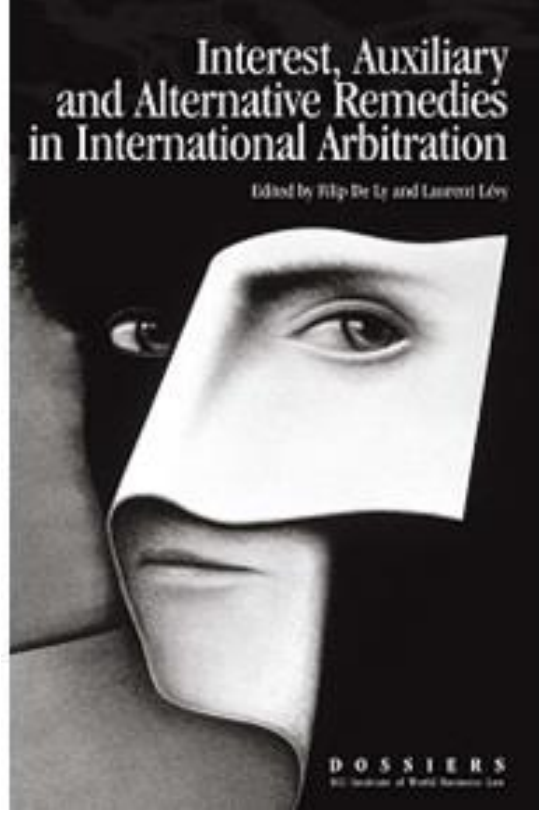

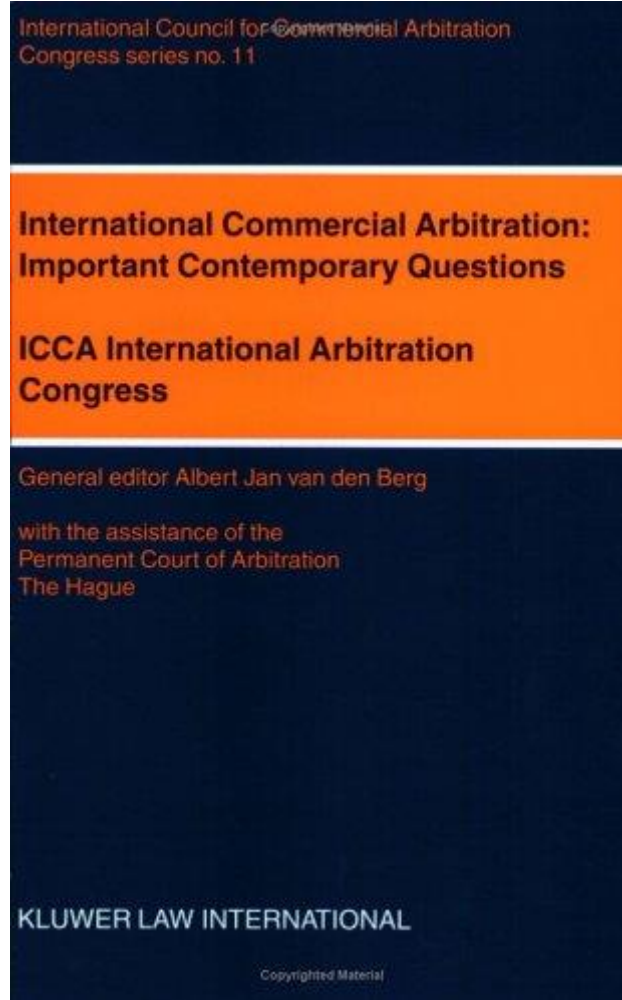

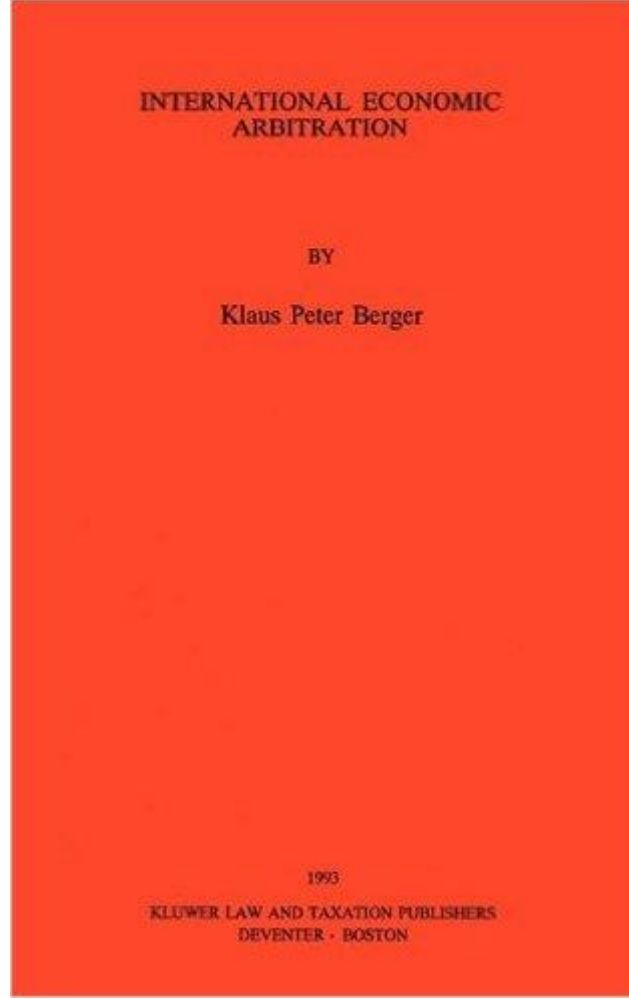

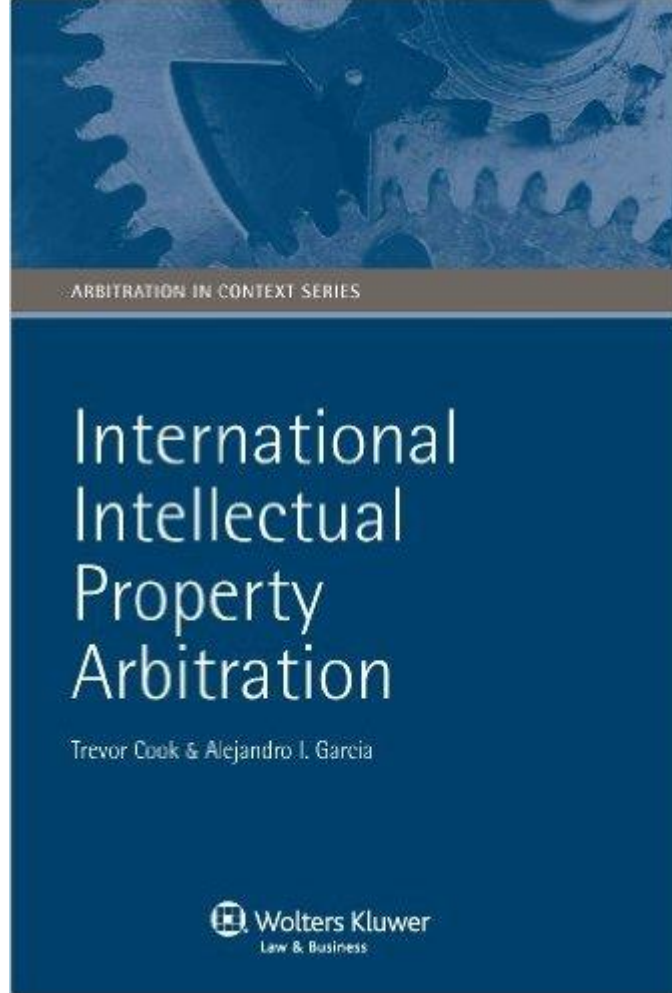

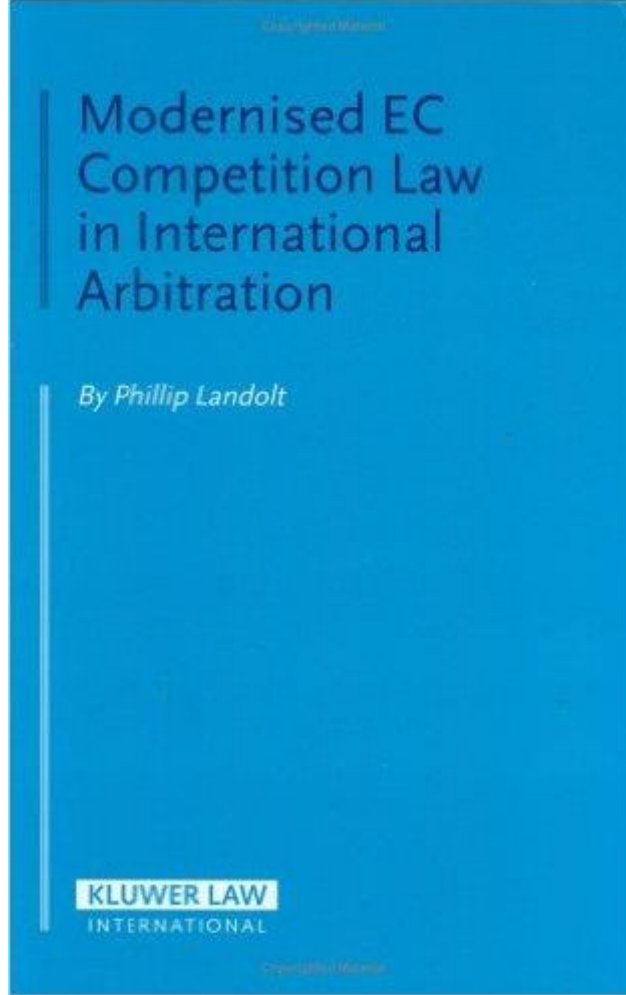

MODERNISED EC COMPETITION LAW IN INTERNATIONAL ARBITRATION

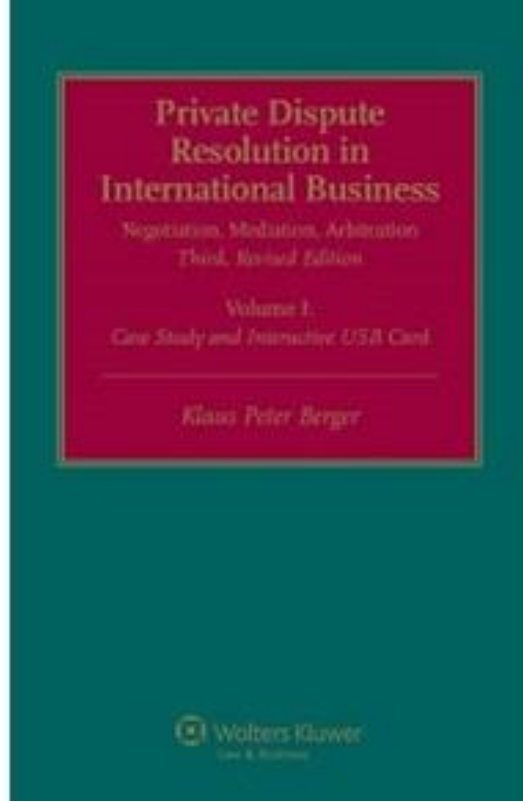
